terms and conditions

1 Exclusive Photographer

Robinson Photo shall be the exclusive photographer retained by the Client for the purpose of photographing the wedding. Family and friends of the Client shall be permitted to photograph the wedding as long as they shall not interfere with the Photographer's duties and do not photograph poses arranged by the Photographer.

2 Deposit and Payment

The Client shall make a \$500 deposit to retain Robinson Photo to perform the services specified herein. The deposit shall be applied to reduce the total cost, and Client shall pay the balance due no later than 1 week prior to the wedding. Please be prepared to pay by check as at this time we do not accept credit cards.

3 Cancellation

If the Client shall cancel the event, for any reason, the deposit shall not be refunded. If the Client should cancel prior to 3 months of the wedding day, only the deposit will be forfeited. If cancellation occurs within 3 months of the wedding, 50% of the remaining balance will be due to accommodate for lost wages, unless another wedding can be booked.

4 Photographic Materials

All photographic materials, including but not limited to digital files, proofs, and albums, shall be the exclusive property Robinson Photo. The Photographer may, with the Client's permission, make the proofs available on a website.

5 Copyright and Reproductions

Robinson Photo shall own the copyright in all images created and shall have the exclusive right to make reproductions. Robinson Photo shall only make reproductions for the Client or for the Photographer's portfolio, samples, self-promotions, entry in photographic contests or art exhibitions, editorial use, or for display within or on the outside of the Robinson Photo studio. If the Robinson Photo desires to make other uses, Robinson Photo shall not do so without first obtaining the written permission of Client.

6 Clients Usage

The Client is obtaining prints for personal use only, and shall not sell said prints or authorize any reproductions thereof by parties other than Robinson Photo. If Client is obtaining a print for newspaper announcement of the wedding, Robinson Photo authorizes Client to reproduce the print in this manner. In such event, Client shall request that the newspaper run a credit for the Robinson Photo adjacent to the photograph, but shall have no liability if the newspaper refuses or omits to do so.

7 Failure to Perform

If Robinson Photo cannot perform this Agreement due to a fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to Photographer's illness, then Robinson Photo shall return the deposit to the Client but shall have no further liability with respect to the Agreement. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the Photographer. In the event Robinson Photo fails to perform for any other reason, the Photographer shall not be liable for any amount in excess of the retail value of the Client's order.

8 Photographer

Robinson Photo may substitute another photographer to take the photographs in the event of Photographer's illness. In the event of such substitution, Robinson Photo warrants that the photographer taking the photographs shall be a competent professional.

9 Standard Price List

The charges in this Agreement are based on Robinson Photo's Standard Price List. This price list is adjusted periodically and future orders shall be charged at the prices in effect at the time when the order is placed.

10 Inherent Qualities

The Client is aware that color dyes in photography may fade or discolor over time due to the inherent qualities of dyes, and the Client releases Photographer from any liability for any claims whatsoever based upon fading or discoloration due to such inherent qualities.

11 Miscellaneous

This Agreement incorporates the entire understanding of the parties. Any modifications of this Agreement must be in writing and signed by both parties. Any waiver of a breach or default hereunder shall not be deemed a waiver of a subsequent breach or default of either the same provision or any other provision of this Agreement. This Agreement shall be governed by the laws of the State of Arkansas
